**Warranty Terms and Conditions:**

Stay-Tuff wire fence products which include fixed-knot wire fence, field fence, and barbed wire purchased from an authorized dealer or contractor are warranted to the original purchaser for a period of ten (10) years from the date of purchase. The warranty will provide coverage against defects in materials and workmanship. Normal wear, tear, abuse and/or misuse are not covered by the warranty.

Prompt notification shall be given to Stay-Tuff Fence Mfg Inc. of any defective product. Stay-Tuff Fence Mfg Inc. agrees to repair or replace at its option any goods covered by this warranty within 30 days of such notification.

Please read the following instructions carefully. This **Warranty is Void** under the following conditions:

- In the event that the fence is installed other than strictly in accordance with the manufacturer's guidelines.
- If the product is used for any purpose other than as a fence.
- If any product defects arise from conditions or use other than those considered to be normal working conditions. Misuse and damage by flood, fire or acts of god are not covered by the warranty.
- Damage sustained while in transit or on the merchant's premises.
- If the Warranty Registration Card is not completed and returned to Stay-Tuff Fence Mfg Inc. within 60 days of purchase date, together with one original product label for each fence specification purchased, plus a copy of your purchase receipt.

This warranty does not cover any consequential loss or damage howsoever arising and is strictly limited to the value of product supplied excluding freight, removal, and installation charges. (Some States do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.)

This warranty gives you specific legal rights and you may also have other rights which vary from State to State.
